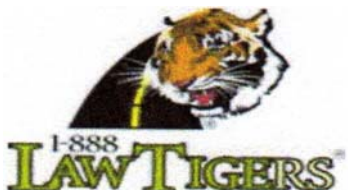

The exhibitor hereby applies to the producer of the bike show referred to above to have the vehicle described above displayed therein and agrees that, if the application is accepted, he/she will display the motorcycle at the show under the following terms and conditions:

1. In accordance with paragraph 5 below, producer and all other parties affiliated with Motorcycle Mania shall not be responsible for damage or loss to any other exhibitor's property.
2. Exhibitor agrees to be bound by the rules, regulations and policies of the producer including, but not limited to, the standards for determining categories and classes of the bike show entries as well as the winners of each such category or class.
3. The producer shall have the final authority to determine the location of the exhibitor's display within the show.
4. Exhibitor's motorcycle and accompanying display shall not be removed or concealed by the exhibitor prior to the end of the show without the permission of the producer.
5. Neither the producer, Levenbaum & Cohen d/b/a the Law Tigers®, the Maricopa County Sheriff's Association, Maricopa County Sheriff's Office Youth Assistance Foundation, the City of Phoenix or their employees, agents, officers, directors or shareholders, shall be responsible or liable for any loss of damage to all or any part of the exhibitor's property, which shall include, but is not limited to, the exhibitor's motorcycle, vehicle, trailer, display, materials and/or parts; and exhibitor hereby waives all rights exhibitor may have against them or any of them for any

such loss or damage. Exhibitor agrees to obtain and maintain its own insurance covering the above property and assumes full responsibility for any loss or damage. Exhibitor agrees that this signed entry blank supersedes any and all prior and/or contemporaneous agreements and understandings whether written or oral between exhibitor and the producer, the producer's employees, show staff, representatives and subcontractors. Nothing herein shall be modified unless consented to by producer in writing. Both parties agree all disagreements will be decided by arbitration in the state where the show is produced.

6. No commercial advertising is allowed with entries unless they are appearing in conjunction with paid commercial space. A single sign may be used to identify major modifications, who did them, and what equipment was used, but large ad signs, handbills, or business card distribution is prohibited.
7. In consideration of this entry, the owner, spouse and any guests agree to permit the Law Tigers® or its assigns the use of their names and pictures of the entered motorcycle for publicity, advertising and commercial purposes (including newspapers, magazine, radio, internet and television) before, during and after the event, and do hereby relinquish any rights whatsoever to any photos taken in connection with the event, and give permission to publish or sell, or otherwise dispose of said photographs to the Law Tigers® or its assigns. All publicity and advertising rights are reserved by the Law Tigers® or its assigns.
